Association for Healthcare Philanthropy Announces 2013 Board of Directors

WASHINGTON, D.C., November 13, 2012 – The Association for Healthcare Philanthropy (AHP), representing more than 5,000 executives of philanthropic programs in North America supporting not-for-profit hospitals, clinics, health systems and related facilities, has announced its recently-elected board of directors.

AHP is the leading authority for standards, knowledge and leadership in health care philanthropy. As the world's largest association for health care fundraising professionals, AHP members raise more than \$9 billion each year for community health services. AHP supports its members and serves the public through high performance standards, expert knowledge development and executive leadership that advance the practice and performance of health care philanthropy at both the local and national level.

The AHP board of directors is the association's chief policy-making body, with overall responsibility for ensuring that AHP's business, property and affairs are managed in a manner consistent with its purpose, bylaws and applicable laws. Officers serve one-year terms and regional directors serve for two years.
