Association for Healthcare Philanthropy Recognizes Dana R. Todsen with Highest Distinction – the AHP Fellow

WASHINGTON, D.C. (October 20, 2011) -- The Association for Healthcare Philanthropy (AHP) will present Dana R. Todsen of Catholic Health Initiatives Foundation, Edmond, Okla., with the "Fellow in AHP" (FAHP) medallion at a ceremony Oct. 20 in Boston during the association's annual international conference.

Todsen earned the FAHP status based on his outstanding career record and after passing rigorous oral and written examinations as a development professional in the health care field.

"Elevation to the status of Fellow in AHP is the highest level of achievement in the field of health care philanthropy," said William C. McGinly, Ph.D., president of the association. "Conferring of the Fellow designation is not so much an award as it is recognition of individual professional distinction, well earned through dedication and continual self-advancement."

Todsen is interim president/CEO and regional vice president, CHI Foundation. Todsen has more than 30 years of successful experience in the design and management of strategic philanthropic programs including major gift and capital campaigns.

Todsen is currently the Catholic Health Initiatives Foundation, Colorado Springs, interim president/CEO overseeing all CHI hospital foundations throughout the United States. He is also the CHI regional vice president for hospital foundations located in Iowa, Kansas, Nebraska, Oregon, and Washington. Catholic Health Initiatives is the second largest Catholic health care system in the United States with 73 hospitals and 40 long-term care and residential living facilities with annual revenues of approximately \$9 billion.

Previously, he served as the president of Integris Health Foundation, Oklahoma's largest health care delivery system with 14 acute care hospitals. He also served as the vice president of development for Children's Healthcare of California and as president of the Baptist Health Foundation in Birmingham, Alabama. He organized the Memorial Health Foundation in Savannah, Ga. where he served as its president. He was also the founding chief development officer at the Moffitt Cancer Center in Tampa, Florida.

Todsen has served the Association for Healthcare Philanthropy as the associate dean and major gift track faculty member at the AHP Madison Institute from 2003 to 2010; as the major gift track dean for the 2008 AHP International Educational Conference Advisory Council; as well as, various AHP regional cabinet and conference education positions.

Todsen was one of the first professionals to attain the Advanced Certified Fund Raising Executive (ACFRE) designation and is a former member of the international board of directors of the Association of Fundraising Professionals. Additionally, he served as an executive coach to donor-investors and trustees for the Brighton, Colorado-based Kaiser Institute Program in Philanthropy. He also served as faculty member for the Institute for Charitable Giving annual seminar Designing a Successful Capital Campaign.
